

1. Residence permit (issued for the first time)

You want to apply for a fixed-term residence permit for a particular purpose.

General information:

Prerequisites:

You are officially registered as having your main abode in Frankfurt (Oder) and you are in possession of a valid passport with a valid visa or are exempt from the requirement to have a visa.

An application to be issued with a residence permit must be submitted in person at:

Documents required:

- Application form
- Passport with valid authorisation to stay (entry via visa procedure)
- Two up-to-date biometric passport photographs
- Tenancy agreement
- Proof of a secure means of financial support from your own gainful employment, your own assets or other personal means
- Proof of an appropriate reason to reside e.g. family reasons (marriage certificate, custody declaration for child, proof of paternity), study (certificate of enrolment, notice of grant approval), training (articles of apprenticeship), gainful employment (work contract), for self-employed individuals: power of attorney from the company + current excerpt from the relevant register (register of companies, associations or cooperatives); a request may also be made for a partner contract + business plan + confirmation from an accountant of current earnings of the legal person (based on a business assessment), humanitarian reasons
- Health insurance certificate

2. Residence permit (extension or change in the purpose of stay)

You are in possession of a valid, fixed-term residence permit and want to apply for an extension (if necessary, because of a change in the purpose of stay).

You are officially registered as having your main abode in Frankfurt (Oder) and are in the possession of a valid, fixed-term residence permit.

An application to be issued with an extension to a residence permit must be submitted in person at:
